The Plymouth County Commissioners are pleased to present the 2018 Cooperative Procurement Offering of Public Service and Municipal Vehicles with Equipment Options: Contract 18-19-20. The cooperative group has been in place for over 25 years and helps over 300 municipalities and organizations purchase over 1,500 vehicles per year. Our group is one of the largest in the northeast and brings all the purchasing power together for you to receive great pricing and service. The program saves your municipality and organization money while complying with all aspects of Massachusetts General Laws, Chapter 7, section 22B and Chapter 30B.

This is a rolling admission program, so no town is locked out of ordering.
